GRAND KNIGHT HANDBOOK REINSTATEMENT—This transaction can be used if membership termination has been for a period of three months or less. To reinstate his membership, the applicant pays to the financial secretary of his former council all arrearages, whereupon the financial secretary shall notify the Supreme Council office on a Form #100.
