Use the CODIS Hit Follow Up Survey to provide electronic notice to the NC State Crime Laboratory within 15 days of an arrest and within 15 days after a conviction resulting from a CODIS Hit.

Meth labs range in size from small to large, and may be stationary or mobile. Meth labs are often located in duffle bags or plastic storage totes.

In 1977, the state crime laboratory moved to the Garner Road campus as well. To assist law enforcement in processing crime scenes, the SBI added a Mobile Crime Lab, one of the most used services. The Air Wing Unit was started in 1976 to investigate and fight high-level drug trafficking in North Carolina.
